



The Blue House: Self-Assessment Form 2024/25

This self-assessment form should be completed by the complaints officer, and it must be reviewed and approved by the landlord's governing body at least annually.

Once approved, landlords must publish the self-assessment as part of the annual complaint's performance and service improvement report on their website. The governing body's response to the report must be published alongside this.

Landlords are required to complete the self-assessment in full and support all statements with evidence, with additional commentary as necessary.

**It should be noted that in this assessment, if the evidence is stated as being the "Residents' Complaints Policy & Procedures" then no commentary / explanation is given as the explanation is within the document, as published on the Blue House Website.*
